FOREIGN DIRECT INVESTMENT 1998 - 1999

1. INTRODUCTION

Foreign direct investment in 1998

The summary of foreign direct investment in 1998 was prepared within the structure used by EUROSTAT and OECD and compiled on the basis of a statistical survey conducted at companies fully or partly owned by a non-resident and at companies owning holdings abroad. The result of this survey is a comprehensive summary of foreign direct investment with respect to its territorial and industrial sector structure. For the first time, the allocation of direct investment within the Czech Republic has been broken down by regions and districts.

The submitted data are based on the audited balance sheets for 1998 and have been compiled for 2,062 entities having a foreign investor and 580 entities investing abroad. To achieve a unified base for the territorial breakdown of investment, the country of origin or the destination of investment is derived from the address registered in the Companies' Register. The breakdown by industry is based on the Classification of economic activities by industry. The territorial distribution is derived from the registered address of the company in the Czech Republic given in the Companies' Register.

Methodological content of foreign direct investment

Foreign direct investment represents a share of 10 % or higher of a foreign investor in the equity capital of the company, conditional on the investor having a lasting interest in the company and a participation in the management of the company. However, a direct investor needs not own the controlling stake or the largest stake in the company. In addition to the non-resident company's share of the equity capital, reinvested earnings and other capital – covering credit relations with the direct investor – are considered part of the foreign direct investment. The composition of direct investment can thus be expressed by the following relationship:

Direct investment = equity capital + reinvested earnings + other capital

- **Equity capital** includes the non-resident's share of equity of the company and all shares in subsidiaries and associates.
- **Reinvested earnings** consist of the direct investor's share (in proportion to direct equity participation) of the profit (loss), reduced by dividends paid. The calculation of reinvested earnings can be expressed by the following relationship:

Reinvested earnings = current year's profit after tax + retained profit from previous years – current year's loss – accumulated losses from previous years – dividends.

- **Other capital** covers accepted and provided credits, including debt securities and supplier's credits, between direct investors and companies in which they have ownership interest as well as branches and associates. These credit relations are reflected in intercompany claims and liabilities.

Survey results

- **Direct investment of domestic investors abroad** amounted to CZK 24.0 billion, i.e. USD 804 million.

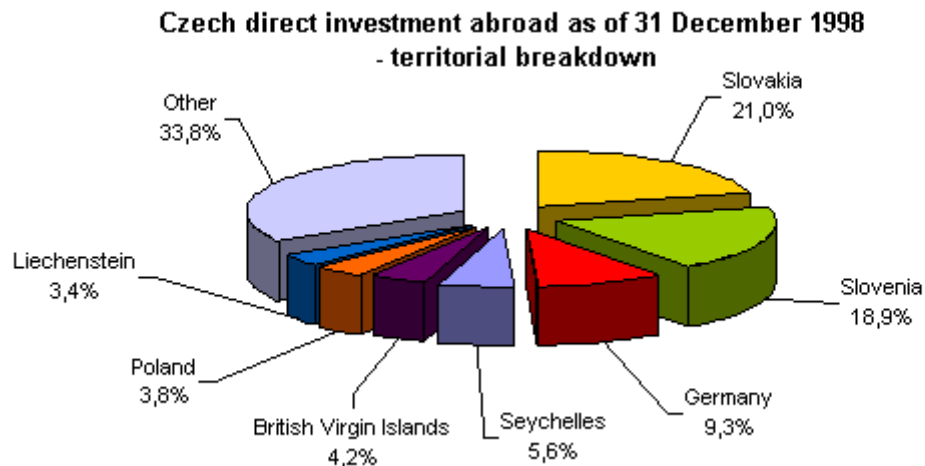

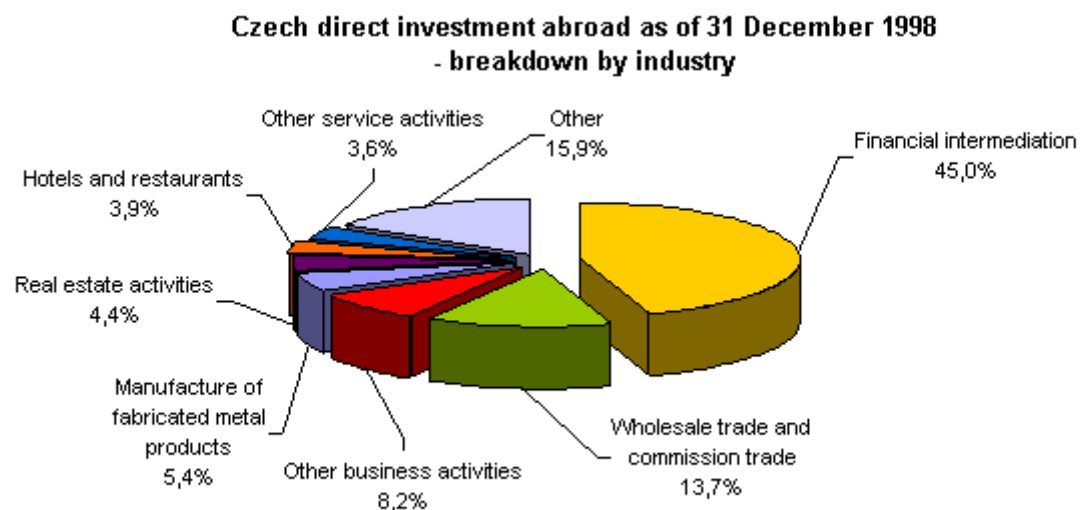

Of the total amount of domestic direct investment abroad, the most was channelled into Slovakia (21.0 %), followed by Slovenia (18.9 %), Germany (9.3 %), the Seychelles (5.6 %), the British Virgin Islands (4.2 %), Poland (3.8 %) and Liechtenstein (3.4 %).



As for the breakdown of direct investment by industry, the largest shares went into financial intermediation (45.0 %), wholesale trade and commission trade (13.7 %), other business activities (8.2 %), manufacture of fabricated metal products (5.4 %), real estate activities (4.4 %), hotels and restaurants (3.9 %) and other service activities (3.6 %).



- **Foreign direct investment in the Czech Republic** as of 31 December 1998 stood at CZK 429.2 billion, i.e. USD 14.375.1 million.

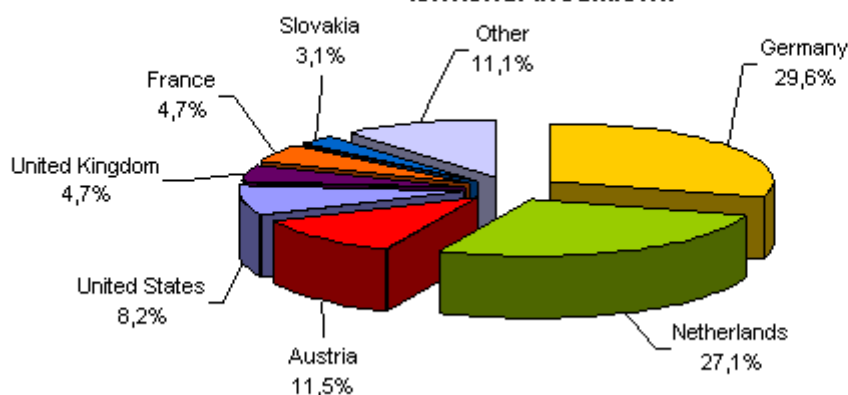

Within the territorial structure of foreign direct investment, the largest investments came from Germany (29.6 %), the Netherlands (27.1 %), Austria (11.5 %), the USA (8.2 %), the United Kingdom (4.7 %), France (4.7 %) and Slovakia (3.1 %).

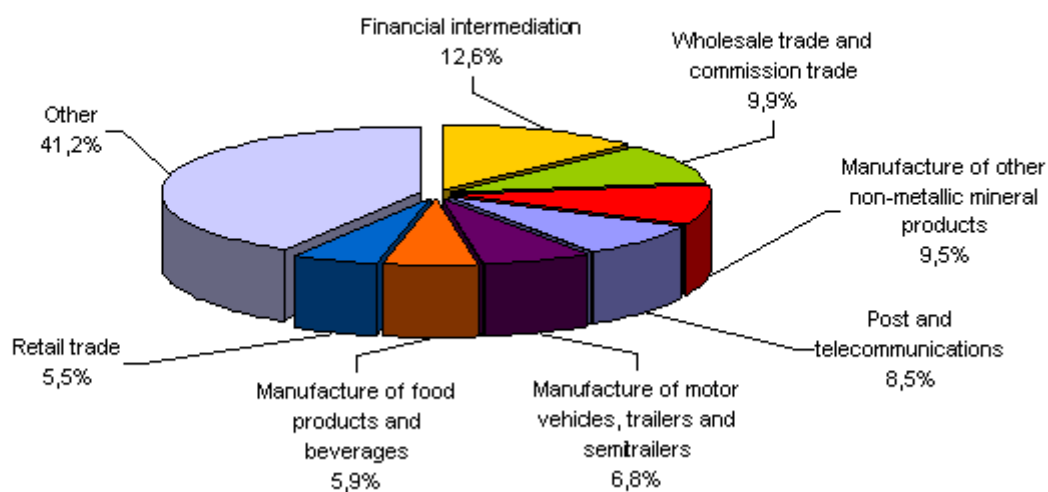
Foreign direct investment in the Czech Republic as of 31 December 1998 - territorial breakdown



By industry, the largest shares of foreign investment went into financial intermediation (12.6 %), wholesale and commission trade (9.9 %), manufacture of other non-metallic mineral products (9.5 %), post and telecommunications (8.5 %), manufacture of motor vehicles, trailers and semitrailers (6.8 %), manufacture of food products and beverages (5.9 %) and retail trade (5.5 %).

Within other industries, the most dominant are electricity, gas, steam and hot water supply, manufacture of electrical machinery and apparatus, real estate activities and manufacture of fabricated metal products.

The distribution of foreign direct investment in the Czech Republic indicates that approximately 47 % of capital is linked to entities having their registered address in Prague. This distribution is affected mainly by the capital of banks, insurance companies and foreign owned investment funds and in the telecommunications area. The remaining part is distributed to all regions, although there are large differences in the volumes of direct investment by individual regions.
