FOREIGN DIRECT INVESTMENT

1. INTRODUCTION

Orientation and content of the publication

The annual publication *Foreign Direct Investment* provides an in-depth survey of foreign direct investment in the Czech Republic and domestic investment abroad. The publication has been compiled in accordance with the international standards of foreign direct investment statistics.

Foreign direct investment (FDI) is becoming one of the key indicators in quantifying and assessing the effect of globalisation on the world economy. Many economic studies conclude that direct investment fosters growth in efficiency, affects the employment rate, expands production capacities, promotes restructuring, generates export growth and ultimately contributes to GDP growth. FDI is considered particularly beneficial to developing economies, however the main share of the internationally invested capital still goes to the most advanced world economies.

Transition economies are a specific group competing for the maximum share of the international supply of investment capital. A nation's attractiveness to foreign investors is considered an indicator of the stability and soundness of its economy, and the volume of FDI inflow is one of the yardsticks of progress with economic reform. FDI is also significant because of the mass privatisation of state assets in the former command economies.

The main reasons for the need for reliable, comprehensive and up-to-date data on FDI can be summarised as follows:

- the significance of direct investment for the national economy,
- the special role of FDI inflows in transition economies,
- to indicate the nation's standing within the world economy,
- to improve the quality of data for the compilation of the nation's balance of payments,
- the requirements of international organisations regarding FDI data,
- the interconnection of the FDI statistics with other statistical systems (statistics on foreign affiliates, globalisation).

The growing demand for comparable, high-quality and up-to-date FDI data has prompted the introduction of joint EUROSTAT/OECD questionnaires on direct investment stocks, flows and income. Closely linked with the area of FDI reporting is the issue of quantifying the globalisation process as well as the statistics on foreign affiliates. In 1998, the CNB changed its FDI reporting methodology in order to harmonise the Czech FDI statistics with international standards. As from 1997, the reporting duty to international organisations in the area of FDI stocks has been met to the full extent for all required indicators. In 1999, the Czech Republic became one of the first OECD and IMF member countries to start submitting data on statistics on foreign affiliates (FATS Statistics).

The publication *Foreign Direct Investment* consists of five sections. The first two sections contain summary and cross-sectional tables with data on stocks of direct investment abroad and in the Czech Republic broken down by economic activity and territory. The next section presents data on direct investment flows in the reference year. The following section gives time series for FDI stocks and flows since the establishment of the Czech Republic in 1993. The last section includes selected indicators for foreign affiliates in the services sector.

Definition of foreign direct investment

The CNB bases its FDI statistics on the definition of foreign direct investment set by the OECD in harmony with EUROSTAT and the IMF. This definition specifies that:

“Foreign direct investment reflects the objective of obtaining a lasting interest by a resident entity in one economy (“direct investor”) in an entity resident in an economy other than that of the investor (“direct investment enterprise”). The lasting interest implies the existence of a long-term relationship between the direct investor and the enterprise, and a significant degree of influence on the management of the enterprise. Direct investment involves both the initial transaction between the two entities and all subsequent capital transactions between them and among affiliated enterprises, both incorporated and unincorporated.” A direct investment enterprise is defined as “an incorporated or unincorporated enterprise in which a foreign investor owns 10 per cent or more of the ordinary shares or voting power of an incorporated enterprise or the equivalent of an unincorporated enterprise.”

A direct investment enterprise includes directly and indirectly owned affiliates. These are divided – according to the investor’s percentage ownership of the ordinary shares or voting power – into subsidiaries (more than 50%), associates (10%–50%) and branches (wholly-owned permanent establishments or offices of a direct investor; land and structures directly owned by a foreign resident; or mobile equipment that operates within an economy for at least one year).

In addition to shares in equity capital, foreign direct investment covers reinvested earnings and other capital, including lending transactions with a direct investor. The composition of direct investment can thus be expressed using the following relationship:

$$\text{Direct investment} = \text{equity capital} + \text{reinvested earnings} + \text{other capital}$$

- **Equity capital** comprises nonresident investment in the equity of a company and all shares in subsidiaries and associates.
- **Reinvested earnings** consist of the direct investor’s share (in proportion to direct equity participation) of profit (loss) less dividends paid. The calculation of reinvested earnings can be expressed using the following relationship:

$$\text{Reinvested earnings} = \text{current year's profit after tax} + \text{retained profit from previous years} - \text{current year's loss} - \text{accumulated losses from previous years} - \text{dividends}$$

- **Other capital** covers the borrowing and lending of funds, including debt securities and trade credits, between direct investors and their subsidiaries, associates and branches. These transactions are recorded under intercompany claims and liabilities.

Survey results

- As of 31 December 2001, the volume of direct investment by domestic investors abroad was CZK 41.2 billion (USD 1.1 billion; EUR 1.3 billion).


The stock of Czech direct investment abroad amounted to CZK 41.2 billion as of the end of 2001, a sizeable increase of CZK 13.2 billion compared with a year earlier. Investment in the services sector was still much higher than investment in manufacturing. The share of the services sector increased by three percentage points compared to 2000, accounting for almost 90% of the total funds invested abroad in the form of direct investment.

The largest part of the direct investment outflow is being channelled, as ever, into financial intermediation and into wholesale and retail trade and repairs. It thus still holds true that Czech investment abroad is determined primarily by an effort to sell domestic products via trade organisations abroad and by the need to allocate free funds, and is much less directed at the establishment of production facilities.


Turning to the territorial breakdown, Czech direct investment is starting to show a stronger trend towards the placing of free domestic capital in tax havens. The position of investment in neighbouring countries remains stable, with Slovakia having the largest absolute share – almost CZK 10 billion (around 24% of the total). The stock of Czech investment in Poland, Hungary, the Netherlands and Germany accounted for about CZK 1–2 billion.

The overall volume of funds invested abroad is, however, still relatively low, so even a one-off sizeable investment can have a substantial effect on the territorial and industrial structure. This also applies to reinvested earnings, the amount of which shifted from negative to positive figure for the first time in 2001. This result reflects the commencement of several highly profitable investment projects as well as a gradual shift to profitability for investments which, after an initial period of loss-making due to start-up costs, are starting to generate profits or reduce their accumulated losses.



The stock of foreign direct investment amounted to CZK 982.3 billion as of the end of 2001, up by around CZK 164 billion on year earlier. Of this, CZK 65 billion was attributable to a rise in equity capital, CZK 70 billion to reinvested earnings and about CZK 29 billion to loan capital.


The reinvested earnings have exceeded the amount of equity, which represents a unique feature in the history of FDI in the Czech Republic. One of the reasons of this phenomenon is the gradual completion of privatisation and an ensuing decline in investment in equity capital compared to previous years. Moreover, the stock of investment in equity capital is being decreased by disinvestment owing to the dissolution of loss-making companies, which in turn means a rise in the total volume of reinvested earnings. Another significant factor is that an increasing number of companies are dealing with their accumulated losses by decreasing their equity capital. This practice is again leading to a decrease in the value of investment in equity and a rise in the volume of reinvested earnings. The annual growth in the stock of FDI loan capital is stable, fluctuating between CZK 20 billion and CZK 30 billion in 1997–2001.

The overall FDI volume in the Czech Republic represents investment in about 3,700 companies. This group comprises all the foreign investors in the Czech Republic except for statistically insignificant minor entrepreneurs. The 70 largest companies account for around half the total FDI. An analysis of the territorial origin of the foreign investment confirms that the foreign capital of almost one third of the foreign-owned domestic companies comes from Germany, followed by Austria and the Netherlands. In terms of value, the largest investors are the Netherlands and Germany, which account for more than 53% of the capital invested. Almost 85% of the total volume of direct investment in the Czech Republic comes from the EU countries.

As regards the economic sector breakdown, the services sector remains the largest recipient of foreign direct investment, absorbing almost 60% of the total volume of invested capital, as in 2000. Within the tertiary sector, investment in financial intermediation, telecommunications and wholesale and retail trade still predominates, thanks mainly to the volumes of funds invested in banking and telecommunications privatisations, and the rapid development of retail chains. As in the previous year, approximately 38% of the foreign investment was channelled into the production sector, most notably manufacture of motor vehicles and manufacture of oil and other non-metallic mineral products. The remaining 2% of the total was invested in the primary sector, chiefly in mining and quarrying.

The increasing need to quantify the globalisation of the world economy is leading to the use of a wider range of indicators characterising the activity of foreign affiliates in the domestic economy. The basic indicators for assessing the share of foreign-owned companies in the overall performance of the economy include sales, value added, exports, imports and the number of persons employed at foreign affiliates.

A comparison of these indicators reported by foreign-owned Czech companies in 2000 and 2001 reveals that the total sales of these companies increased from CZK 1,730 billion to CZK 1,933 billion, exports of goods and services rose from CZK 535 billion to CZK 646 billion and imports increased from CZK 570 billion to CZK 628 billion. Foreign-owned companies thus generated a surplus of CZK 18 billion on the balance of goods and services in 2001, compared to a CZK 34 billion deficit in 2000. A deficit in services was exceeded by a surplus in manufacturing. The 2001 trade surplus recorded by foreign-owned firms represents a major shift compared to the 2000 deficit. The registered number of employees grew from 574,000 to 614,000.

As regards foreign investors' interest in domestic companies with respect to size, about 65% of the total FDI volume is concentrated in large companies (with more than 250 employees). Medium-sized enterprises (with 51–250 employees) account for 13% of the foreign capital allocation, and the remaining 22% is channelled into small enterprises (with less than 50 employees) and firms with no employees. Foreign owners have a major influence in most of the foreign-owned companies. More than 65% of the enterprises are wholly foreign-owned, and a further 24% are more than 50% foreign-owned.
